- b) Copy of register for your residence in Japan (in case of you own your residence in Japan)
- c) Copy of rental agreement for your residence in Japan (in case of you rent your residence in Japan)

- Documents printed after entry for "ToR1" (Please see next page for details)
- Copy of U.K. Visa (if you are non U.K. citizen, Visitor Visa is not acceptable.)
- Proof of your address in U.K.

Please prepare one of the following documents.

Photocopies of any of the following documents that can prove your residence in the U.K.

a) If you have a fixed place of residence: Utility bills, bank statements, rental agreement, etc.
dated within the last 3 months.

b) For those who do not have a fixed place of residence: Reservation slip for a short-stay accommodation
or a letter from the person staying and his/her proof of address.

About entry for form "ToR1"

In case of sending personal belongings from outside U.K., registering "Application for Transfer of Residence relief (ToR1)" is mandatory.

If you are sending personal belongings multiple times, you will only need to apply the form "ToR1" once.

Flow of entry for form "ToR1"

Japan

1. Please enter the form "ToR1" and print out the form.

* If you are not be able to print out the form, please send PDF file by E-mail.

Notice : The address of U.K. you are filling in the form of ToR1 needs to be the same as you show in the proof of your address in U.K.

2. Please put the form "ToR1" (after print out) with another documents in box No.1 by the time of pick up of your shipment.

U.K.

3. Yamato U.K. will apply to U.K. Customs office with your documents. Usually, it will take 3 or 4 weeks from apply to get unique information from U.K. Customs office.
4. U.K. Customs office will send you unique information for import declaration by E-mail.

Notice : If you are not be able to get unique information, additional fee for import customs clearance will be charged. (The amount will vary depending on your items.)

5. Please transfer your unique information to Yamato U.K. by E-mail.
