Delivery area

This service is available for Kuala Lumpur(including Selangor), Penang Island, Johor Bahru only.

Shipping condition

- You need to book the flight to Malaysia or within 6 months after your departure from Japan. You need to prepare following required documents.
- You need to enter in Malaysia or within 6 months after your arrival to Malaysia for import customs clearance in Malaysia.
- If you don't have Japanese nationality, you need to have lived in Japan at least 6 months.

• If you are Malaysia Citizen: Copy of IC (both sides), copy of Japanese Visa(or copy of Zairyu Card),	
and copy of immigration stamp by Malaysian Officials	
 If you will work in Malaysia : Copy of Employment Pass 	
If you will study in Malaysia : Copy of Student Pass	
 If you will permanent reside in Malaysia: Copy of PR card or Copy of MM2H Visa

- 2) Documents required in Malaysia for import
 - * Usually, nothing will be required. Unless, if in case of need some another documents for clearance, our staff in Malaysia will contact you.

MALAYSIA

Prohibited articles

Food and Beverages	Any food and beverages(includes supplement)
Books and Documents	Pornography and politically inflammatory literature
Valuable items	Cash, securities, stock certificates, bills, precious metals, antiques, items difficult to assign a value
Dangerous items	Aerosols, fireworks, guns (includes models), swords (includes models and stun guns), flammable items, matches, lighters, gas canisters, ignitable items
Chemicals	Poisonous items, deleterious items, controlled substances
Other items	Live animals and plants, items that contain materials (bone, horns, tusks, leather, fur) made from animals and plants protected by the Washington Convention(Convention on International Trade in Endangered Species of Wild Fauna and Flora), soil (take care with items that may have soil adhered to them), perishable items, items that require import license / certification, tobacco, seeds of plant, large quantities of medicine, electric power assisted bicycle, straw articles, radio which can receive FM broadcasting

*Another article with special care

- Any foods, beverages(includes supplement), medicines won't be accepted for removal shipping to Malaysia. If found by customs inspection, you will be fined.
 Please note that you will be subject to punishment if it is determined to be vicious.
- Brand new electrical appliances and furniture may be taxable items.
 - It will take longer time for import customs clearance due to inspection.
- You can take medicines(without prescription), articles for Contact lens care and cosmetics.
 Unless the quantity you can take will be just for one month only.
- © Videos(DVDs, videos, Blurays etc.) may take an inspection.

 It will take longer time for import customs clearance and extra charge for inspection will occur.
- O Telephone and facsimile made in Japan are prohibited to use in Malaysia.
