### **Delivery area**

This service is available for Singapore island only (excluding Sentosa and other small islands).

### **Shipping condition**

- You need to book the flight to Singapore or within 6 months after your departure from Japan.
- If you have Singapore nationality or permanent residency, you need to have lived in the countries outside Singapore(includes Japan) at least 6 months.
- You will be able to ship out only one time for ocean shipment.(includes ship out by another company) Second ocean shipment will be taxable shipment.
  - If you would like to ship out twice, you need to change shipper's name to your spouse's name.
- If you will take Employment Pass, S Pass, Dependant's Pass or Student Pass which expire
  at least 6 months, and your arrival date or issuing date of Pass within 6 months,
  your shipment will be non taxable.

#### **Prohibited articles**

Food and Beverages	Meat, meat products, fish, fish products, vegetable, vegetable products, seed, dairy products, rice, alcoholic beverages.  * The customs process will take longer if foods are included, as they will be inspected. Also we cannot accept large quantity of foods (we can accept only one or two carton boxes quantity).
Books and Documents	Pornography and politically inflammatory literature
Valuable items	Cash, securities, stock certificates, bills, precious metals, antiques, items difficult to assign a value
Dangerous items	Aerosols, fireworks, guns (includes models), swords (includes models and stun guns), flammable items, matches, lighters, gas canisters, ignitable items
Chemicals	Poisonous items, deleterious items, controlled substances
Other items	Live animals and plants, items that contain materials (bone, horns, tusks, leather, fur) made from animals and plants protected by the Washington Convention (Convention on International Trade in Endangered Species of Wild Fauna and Flora), soil (take care with items that may have soil adhered to them), perishable items, items that require import license / certification, tobacco, seeds of plant, large quantities of medicine, antibiotics, hypodermic syringe, transceiver, articles with pig hair, electric power assisted bicycle



There are strict regulations for importing video media. If you wish to include videos (DVDs, videos, Blurays etc.) in your shipment, you will need to prepare the declaration forms.

### \*Another article with special care

- © Brand new electrical appliances may be taxable items. It will take longer time for import customs clearance due to inspection. Also, the inspection fee will occur.
- You can take medicines (without prescription), articles for Contact lens care and cosmetics.
  Unless the quantity you can take will be just for two months only.
- Notice for delivery: The charge for using lift (elevator) will be charged at some condominium.
  If it will occur, we will charge you separately.
